

Farmers' Market Nutrition Program (FMNP) Training 2010

The Arizona Farmers' Market Nutrition Program provides vouchers for low-income women, children and seniors to buy fresh, locally grown fruits and vegetables from approved growers at farmers' markets. The goal is to encourage these women, children and seniors to eat more fruits and vegetables, and to support local growers and markets. Growers who wish to participate must attend face-to-face training with a FMNP representative and enter into written agreement with the Arizona Department of Health Services. Market Managers must also be trained and sign a written agreement with ADHS in order for their farmers' market to participate in the FMNP.

Starting October 1, 2009, the Farmers' Market Nutrition Program will expand to allow approved growers and farmers' markets to accept, in addition to FMNP coupons, the new WIC Fruit and Vegetable Cash Value Voucher (CVV). **Mandatory** training will be held for **all** FMNP growers and market managers, both those currently approved and those who wish to become approved, in August and September 2009. Multiple training sessions have been scheduled in various locations in an attempt to accommodate the schedules of growers and market managers.

If you are already an approved market manager or grower, please select the "Session II: WIC CVV's in Farmers' Markets" that you wish to attend. You are not required to attend the "FMNP" session, but are welcome to do so if you wish.

If you are not yet approved for FMNP, please select one "Session I: FMNP" and one "Session II: WIC CVV's in Farmers' Markets" to attend. You must attend **both** training sessions to be approved.
